REVIEW OF INVESTMENT POLICY

BACKGROUND AND STATUS:

Government Code Section 53646(a) requires that a public entity's investment policy be reviewed annually by the governing body or an investment committee. The CSJVRMA goes through a very extensive annual review process of the Investment Policy which includes the following:

- Staff and Chandler Asset Management representatives review the policy and discuss any proposed changes.

- 4) The policy is reviewed by the Board, and the Board either amends the policy or acknowledges that no amendments are necessary.
