This police forum is recommended for police chiefs, command staff and supervisors.



### Legal Update: Recent Legislation Affecting Law Enforcement

#### **Fall Protection**

Cal/OSHA requires all employers to protect against falls from elevation by one of the following methods: hazard elimination (i.e. using extension poles to do the work from the ground), passive fall protection (guardrails), fall restraint systems (self-retracting lifelines or short lanyards with a full body harness), fall-arrest systems (shock absorbing lanyard with a full body harness), or administrative controls (designated work area with warning lines). In addition, we will cover worksite fall hazard survey and fall protection system selection and application, fall protection equipment, training, and emergency rescue.

#### **Fundamentals of Gas Monitoring**

Course content to include didactic information on recommended safe practices and standards for atmospheric monitoring, including selection of atmospheric monitoring equipment and sensors, criteria of atmospheric monitoring procedures, identification of hazardous atmospheres and target gases, physiological effects of exposure to specific target gases, basics of monitoring for oxygen concentration, flammables, toxic vapors and high dust atmospheres. Program will cover how gas monitoring is essential for confined space work, trenching and excavation work as well as hot work.
