## **Preparing Facilities for Winter Storms**

This presentation, titled "Water Intrusion Prevention and Resiliency," explores the critical role of the building envelope in safeguarding structures against water-related damage. It emphasizes the importance of proactive design and maintenance strategies to enhance the durability and performance of buildings. The discussion begins with roof systems and will briefly touch on waterproofing systems, highlighting their function as the primary barrier against precipitation and detailing best practices such as proper drainage, material selection, and regular inspections. We will address fenestrations—windows, doors, and skylights—as common points of vulnerability, outlining methods for effective sealing, integration with weather-resistant barriers, and performance testing. Finally, it underscores the necessity of a holistic approach to building envelope integration, ensuring continuity across all components and validating performance through rigorous testing. The session concludes by reinforcing that water intrusion prevention is not merely about stopping leaks, but about fostering resilient, long-lasting structures that protect both property and occupants

Instructors will build on the foundation provided and incorporate a practical safety and risk control lens — focusing on how work order documentation supports not only compliance, but real-time decision making, accountability, and defensibility in the field.

By the end of this session, participants will understand how proper work order documentation for inspections, maintenance, and repairs establishes notice, response, and corrective action—key elements used to demonstrate reasonable care and defend public entity liability claims involving alleged dangerous conditions of public property. The intent is demonstrating how a sound work order system can help minimize and defend against premises liability claims. We would also like to incorporate the safety and risk control aspect of work orders.

### **Child Molestation and Abuse Prevention - Protecting Vulnerable Populations**

California municipalities serve thousands of youth each day through parks, recreation, libraries, camps, and community programs—creating both tremendous opportunity and significant responsibility. This session equips municipal leaders and program administrators with a practical, risk-focused framework for preventing abuse and responding effectively when concerns arise. Participants will gain insight into the true scope of child sexual abuse, how offenders groom and exploit organizational gaps, how to identify red-flag behaviors in adults and youth, and how to address peer-to-peer sexual misconduct before it escalates. The session also clarifies how to manage allegations—including the realities of false reports—while upholding due process, complying with California mandated reporting laws, and protecting public trust.

Participants will leave with:

- A clear understanding of how abuse occurs in municipal settings and how offenders operate
- Practical tools to identify and intervene on red-flag behaviors early
- Strategies to prevent peer-to-peer sexual misconduct through supervision and environmental safeguards
- Guidance on responding to disclosures, documentation, and mandated reporting requirements
- Actionable steps to strengthen policies, training, and organizational culture to reduce risk
